



SUMMIT GLOSSARY

Environmental Justice focuses on the root causes of the climate crisis through an intersectional lens of racism, classism, capitalism, economic injustice, and environmental harm. – *A People's Orientation to a Regenerative Economy*

Climate Justice is the international movement of low-income communities and communities of color standing in solidarity against hazardous environmental and infrastructure burdens of environmental amenities and equity confronting their communities. – *NY Renews*

Just Transition is a vision-led, unifying and place-based set of principles, processes, and practices that build economic and political power to shift from an extractive economy to a regenerative economy... The transition itself must be just and equitable; redressing past harms and creating new relationships of power for the future through reparations. – *Climate Justice Alliance* Protection Act (CLCPA or Climate Act)

is among the nation's most aggressive climate and environmental justice laws. The CLCPA, commonly referred to as NY's landmark climate law, was passed after years of campaigning by NY Renews. The CLCPA commits to 100% zero-emission electricity by 2040, sets legally binding emissions reduction standards to get New York completely off of fossil fuels by 2050, and mandates that at least 35-40% of state climate and energy funding be invested in disadvantaged communities. The CLCPA eventually inspired Justice40 at the federal level. – NY Renews

Local Law 97 (LL97) is one of the most ambitious municipal level legislations for reducing emissions. Under this groundbreaking law, buildings over 25,000 square feet are required to meet GHG emissions limits beginning in 2024, with those limits getting stricter in 2030. LL97's goal is to reduce emissions from the building sector, which contribute to nearly 70% of NYC's overall GHG emissions. LL97 aims to reduce building emissions by 40 percent by 2030 and to net zero by 2050.
